## **Kahibah Public School Student Acceptable Use Agreement for BYOD**

Learning is an ongoing interaction between students, teachers, administrators, and parents. Using mobile technology within education is a tool to help deliver the curriculum. The policies, procedures and information within this document apply to all devices used at school. Individual teachers and administrators may set additional requirements for use in their classroom.

Students must abide by all school rules as outlined in the Kahibah Public School Wellbeing & Discipline Policy and the Kahibah Public School BYOD Implementation Plan (attached).

### **Acceptable Use**

The use of technology resources is a privilege, not a right. This acceptable use agreement is provided to make both students and educators aware of the responsibilities associated with efficient, ethical, and lawful use of technology resources. If a student violates any of the User Terms and Conditions named in this agreement, privileges may be terminated and disciplinary action could be applied. Our Wellbeing & Discipline Policy shall be applied to student violations. When applicable, law enforcement agencies may be involved. Our Kahibah Public School values of Respect, Responsibility and Excellence are expected to be upheld at all times.

### **Students will;**

- Obey general school RULES and VALUES concerning behaviour and communication that apply to ALL OTHER LEARNING at school.
- Use mobile devices in the way that the teacher requests – RIGHT APP, RIGHT TIME.
- Bring the device CHARGED.
- Ensure the camera roll is cleared of all inappropriate images BEFORE the device comes to school.
- Students are not to access SOCIAL MEDIA APPS whilst at school, many of these are 13+yrs.
- All MUSIC must be free of EXPLICIT LANGUAGE.
- Never use the device in the playground, during school unless supervised by a teacher.
- Keep the device safe in a case and in a classroom storage area. Use all technology resources in an appropriate manner so as to not damage the devices, such as dropping, scratching or leaving the device unattended.
- Seek permission to photograph another classmate and never publish a classmate's image online.
- Never google inappropriate images. If an inappropriate image is found accidentally, close the window immediately and tell a teacher. Never show an inappropriate image to another student.
- Never post or record inappropriate material which may offend others, such as racist, violent, sexual or disrespectful images or comments.
- Never use instant messaging at school.

## Network Connectivity

- Students are allowed to access the school's network with the permission of the school principal, and the classroom teacher. Students must never use other WIFI connections such as 3G or 4G connections, only DETNSW.
- The wireless capacity of iPads enables students to access the internet for information and research and to connect with their peers to communicate and collaborate. With this increased capacity to connect comes an increased need for students to understand the ethical and legal (including privacy and copyright) considerations for safe and responsible behaviour online. To protect students from unsuitable content, website filters will operate at school, content will be periodically checked and learning activities supervised.
- All students participate in explicit Cyber Safety lessons in Term 1.
- Students will not have chat facilities to connect online with anyone other than their teacher.

## Parent/Guardian Responsibilities

- Check the camera roll for any inappropriate photos or images. Discuss the age rating and appropriateness of various apps.eg. INSTAGRAM 13+
- Talk to your children about values and the standards that your children should follow on the use of the Internet just as you do on the use of all media information sources such as television, telephones, movies, and radio.
- Support the student through homework and enquiry based learning tasks at home – assignments etc.
- Report any issues or concerns that arise to the Classroom Teacher or Principal as soon as possible.
- SCREENSHOT, BLOCK AND REPORT any issues of concern to the Principal or Police, as appropriate.
